強制性安全訓練課程劃一課程內容 Content of Mandatory Safety Training Courses

為確保強制性安全訓練課程的質素，所有課程營辦機構必須遵守《申請認可強制性安全訓練課程的指引》及《營辦強制性安全訓練課程的批核條件》所規定的課程內容舉辦課程。

勞工處統一擬備考試卷 Central Issuance of Examination Papers by Labour Department
